THE PROGRAM OFFERS ALL CLIENTS THERAPEUTIC SERVICES, LEGAL SERVICES, CASE MANAGEMENT, MEDICAL ACCOMPANIEMENT, ADVOCACY, CRISIS INTERVENTION AND 24 HOUR DAY, 7 DAYS A WEEK RESIDENTIAL SERVICES AND HOTLINE SERVICES. THE PROGRAM HAS TWO SATELLITE OFFICES THAT PROVIDE CASE MANAGEMENT, LEGAL AND THERAPEUTIC SERVICES TO BETTER SERVE THE COMMUNITY. DURING THIS FISCAL YEAR THE PROGRAM RECEIVED APPROXIMATELY 4,785 HOTLINE CALLS AND PROVIDED 8,041 SHELTER DAYS AND ASSISTED 1,080 CLIENTS.
